

**EL DORADO BROADCASTERS, LLC ARIZONA RADIO  
GENERAL CONTEST RULES**

**NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED.**

- a. EL DORADO BROADCASTERS, LLC ARIZONA (KBLU, KTTI AND KQSR)** may change the dates and/or terms of the contest or promotion (the “Contest”) without prior notice. Any material changes will be broadcast on the Station and/or posted on its website located at [www.kbluam.com](http://www.kbluam.com) - [www.kttifm.com](http://www.kttifm.com) - [www.kqsrfm.com](http://www.kqsrfm.com) Unless otherwise specified in Contest rules other station instructions, these general rules will apply to all Station Contests.
- b.** Unless otherwise specified, the Contest is open to all EL DORADO BROADCASTERS, LLC ARIZONA listeners who are legal U.S. residents age 18 or older and who reside in THE LISTENING AREA OF EL DORADO BROADCASTERS, LLC ARIZONA. Employees of EL DORADO BROADCASTERS, LLC ARIZONA (the “Station”), its licensee, its corporate parents, subsidiaries, and affiliates, its advertising agencies, participating sponsors/promotional partners, other radio stations in the YUMA, AZ metropolitan **area and the members of their immediate families and/or households are ineligible to participate or win.**
- c.** Only one winner per household is permitted in any Station Contest.
- d.** For entries by mail, the Station is not responsible for lost, stolen, mangled, misdelivered, illegible, incomplete or late entries. When applicable, the Station is not responsible for telephone service outages, delays, busy signals, equipment malfunctions and any other technological difficulties that may prevent an individual from completing his/her telephone call. When applicable, the Station is not responsible for facsimile transmission errors, illegible entries, telephone service outages, delays, busy signals, equipment malfunctions and any other technological difficulties that may prevent transmitting his/her facsimile entry.
- e.** Upon notification of potential prize award, all prizes or prize certificates may be picked up at the office of the Station at the address below. The winner will forfeit any prize or prize certificate not claimed within forty-five (45) days of winning.
